protection. The foreigner can file a cassation complaints to the Supreme Administrative Court in Brno against the decision of the Regional Court. Having fulfilled the statutory conditions he/she can be issued a visa for the purpose of tolerated residence.

* **Number of foreigners that filed a cassation complaint** – number of foreigner in whose cases the decisions on cassation complaints have not become legally effective yet.

** **Served decisions** = this column also contains older decisions which were served during the given period.

Note: Only cassation complaints on which the MOI had been informed by the courts are registered
