RC - Regional Court

After receiving the negative decision of the Regional Court (after the decision becomes legally effective) the person ceases to be an applicant for international protection. The foreigner can file a cassation complaints to the Supreme Administrative Court in Brno against the decision of the Regional Court. Having fulfilled
