International Protection seekers can bring a suit against the decision of DAMP to an independent appeal body that has been the territorially competent court since 1 January 2003 (given by the place of residence of the international protection seeker at the time of the decision):
 (1) - Regional Court in Praha, Brno, Ostrava, Hradec Kralove, Usti nad Labem, Ceske Budejovice, Plzen, Hradec Kralove - branch office in Pardubice, Usti nad Labem - branch office in Liberec, Metropolitan Court in Praha

* **Number of participants in the proceedings** - includes persons whose suits have not been decided yet by the Regional Court or cases where the decisions have not become legally effective yet; cases which will be decided repeatedly by the Regional Court

** **Served decisions** = this column also contains older decisions which were served on international protection seekers during the given period. After being served with the decision the person stops being an international protection seeker in the Regional Court
