*(1) - Regional Court in Praha, Brno, Ostrava, Hradec Kralove, Usti nad Labem, Ceske Budejovice, Plzen, Hradec Kralove - branch office in Pardubice, Usti nad Labem - branch office in Liberec, Metropolitan Court in Praha*

*\* The number of aliens with an action without suspensive effect = this includes the persons on whose actions the regional courts have not yet ruled or their rulings did not come into force.*
