Aliens can file an action with the regional court against a decision to terminate the proceedings pursuant to Section 25 and against a decision to reject the asylum application as a manifestly unfounded claim pursuant to Section 16(1)(e) and (f) of the Asylum Act; these actions are without suspensive effect.

(1) - Regional Court in Praha, Brno, Ostrava, Hradec Kralove, Usti nad Labem, Ceske Budejovice, Plzen, Hradec Kralove - branch office in Pardubice, Usti nad Labem - branch office in Liberec, Metropolitan Court in Praha
