After receiving the negative decision of the Regional Court (after the decision becomes legally effective) the person ceases to be an applicant for international protection. The foreigner can file a cassation complaints to the Supreme Administrative Court in Brno against the decision of the Regional Court. Having \* **Number of foreigners that filed a cassation complaint** – number of foreigner in whose cases the decisions on cassation complaints have not become legally effective yet.
